CITY OF CAPE TOWN HOME COMPOSTING PROGRAMME - APPLICATION FOR HOME COMPOSTING CONTAINER

The City has embarked on an innovative home composting programme to divert as much household organic waste from landfills as possible. You can get involved by applying for a home composting container, thereby also enhancing your soil condition and making your own compost.

The process:

1. E-mail your signed application form to Wastewise@capetown.gov.za or return it to your nearest subcouncil office or walk-in centre. Remember to attach a copy of your ID.
2. Upon approval of your application, applicants will be issued with:
 - A composting container (unit);
 - A 2 l container for indoor storage of daily kitchen organic waste before composting; and
 - The relevant programme information.
3. The City will deliver the unit to your home within 30 calendar days.

Please note:

This is an additional service **at no cost to you**.

However, qualifying criteria apply:

- It is for single residences and sectional titles only.
- Only homeowners can apply.
- The property must include a secure garden area.
- The garden must include a minimum of 1 m² of open soil (for placement of the unit) and a minimum of 30 m² covered by lawn, plants or greenery.

Terms and conditions

Applicants must agree with the terms and conditions below before a home composting container will be issued **(failure to do so will result in non-delivery of the unit)**.

- The unit must be used solely for the purposes of home composting.
- The safeguarding of the unit is the applicant's responsibility. Stolen and/or broken containers will not be replaced within the first five years.
- A maximum of one home composting container will be issued per qualifying property.
- The onus rests on the applicant to inform the City should your contact details and/or residential location change.
- The applicant may be called on to provide feedback, including estimated volumes composted, as and when required by the City. In order to monitor the usefulness of the unit, the project manager may request to see it, having made an appointment.

NB: Signing the statement on the application form acts as confirmation by yourself as the applicant that your property meets the qualifying criteria and confirms that you agree with the terms and conditions above.
