

TERMS AND CONDITIONS: Howard Centre: Signature Campaign

1. The Promoters of this competition are Howard Centre and X-potential Marketing.
2. Please note that, in order to offer the competition, the Promoters must collect and use the personal information of the participants for purposes of conducting the competition in accordance with the Protection of Personal Information Act of 2013. By entering the competition, participants consent to the Promoters collecting and using their personal information solely for the purpose of offering the competition.
3. By entering this competition, you accept and agree to the following terms and conditions which will govern the competition. Furthermore, you verify that you are unaware of any reason legally prohibiting you from entering this competition and, if the competition requires the submission of photographs, artwork or images of people, or of anything else that requires consent or copyright, that you have the necessary consent and authority to do so, if required. Any entrant who contravenes these rules may be disqualified from the competition.
4. You may only enter this competition if you are a citizen and permanent resident of South Africa, 18 years of age or over. The winner will be required to present a valid South African ID document in order to accept the prize. It is the winner's responsibility to collect the prize from Howard Centre.
5. The competition will run from 27 October 2023 – 30 June 2024. Late entries or incomplete entries will not be accepted.
6. To enter the competition: Spend a minimum of R150 or more at any store or restaurant in Howard Centre four times per calendar month during the competition period as set out above, fill in an entry form and attach all 4 x valid till slips. Drop it into the entry box at the activation area near Wimpy. Our winners will be selected from the end of November 2023 to the end of May 2024, and our grand prize winner will be announced the of June 2024.
7. You can combine multiple till slips to reach the R150 spending requirement. However, please note that we only accept original till slips from stores and restaurants within Howard Centre. Duplicates, photocopies, account payments or gift card purchases will not be accepted.
8. You may enter as many times as you like, but you may not use the same till slips for more than one entry. Incomplete entry forms will not be accepted.
9. Between November 2023 and June 2024, a total of eight (8) winners will be revealed. Seven (7) winners will receive a Howard Hamper worth R2 500 each, while the 8th winner will be awarded the grand prize to the value of R25 000. It is important to note that all monthly participants, including monthly winners, are eligible for the grand prize.

10. Our monthly draws will take place on the last day of each month:
30 November 2023 (*entries from 27 – 31 Oct will be included in the November draw*),
31 December 2023, 31 January 2024, 29 February 2024, 31 March 2024, 30 April 2024, 31 May 2024 and 30 June 2024. The Promoters will make attempts to contact the winners for seven days following the draw. If a winner cannot be reached, fails to respond to messages within that period of time, or chooses to decline the prize, the prize will be forfeited, and a new winner will be drawn.
11. The judges' decision is final, and no correspondence will be entered into.
12. The prize is neither negotiable nor transferable and may not be exchanged for cash.
13. The prize may be subject to additional terms and conditions not mentioned hereunder, but in accordance with relevant South African legislation. The Promoters reserve the right to substitute a prize of equal or greater value if the original prize becomes unavailable for any unforeseen reason.
